The Special Meeting reconvened at 4:50 p.m.

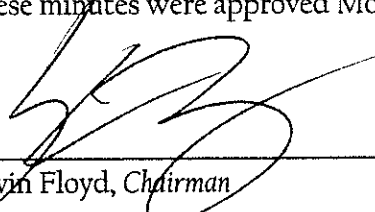
Without objections, Chairman Floyd opened the floor for public comments.

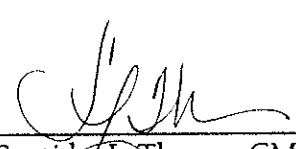
