



**SOUTHERN EDUCATIONAL STRATEGIES, LLC
CONSULTING CONTRACT**

This Contract is entered into by and between Southern Educational Strategies, LLC, a Tennessee limited liability company, and the Board of Education of the Lakeland School System, Lakeland, Tennessee.

Purpose

The Board of Education of the Lakeland School System (herein known as Board) desires the services of Southern Educational Strategies, LLC (herein known as SES) to provide project consulting for the planning and construction of new athletic fields, concessions building, rest rooms, private access roads and parking areas on a site located on the campus of Lakeland Middle Preparatory School, 5020 Lions Crest Drive, Lakeland, TN. The new athletic fields complex design will include one football field, one soccer field, one softball field, one baseball field, and one rectangular shaped practice field. Southern Educational Strategies, LLC has the qualifications to provide such assistance, planning, and consulting services.

Now, wherefore, the Parties agree as follows:

AGREED:

A. Scope of Services. SES will provide consulting project management services to include the following actions:

- Consult with the architects and engineers employed by the Board to provide design services for the Lakeland School System athletic fields complex construction project, and suggest cost efficiencies and value engineering, as appropriate, during the following project design and bid phases:
 - Architectural Program and Schematic Design Phase
 - Design Development Phase
 - Construction Documents Phase
 - Construction Bid Documents Phase
 - Regulatory Approvals Phase
 - Construction Bidding Phase
 - Evaluation of lowest and/or best construction bids phase

- Assist the architects and their construction administration personnel at on-site construction progress meetings during the construction phase;
- Provide, as needed, construction progress updates for the Board and Superintendent; and,
- Assist with the processes to acquire furniture, fixtures, and equipment for the Lakeland School System athletic fields complex.

The services provided and the communication with SES partners may occur in person, by telephone, or by other electronic communication means.

B. Payment for Services. The Board agrees to pay a fee of \$3700.00 per month (payable in monthly payments) for the services described in Section A. SES will submit invoices for each prior month's services to the Lakeland School System Superintendent within the first 10 business days of each month. Payment for services shall begin September 1, 2017 and shall conclude during the month that a final certificate of occupancy for the Lakeland School System athletic fields complex is issued to the Board of Education of the Lakeland School System. Payment for a partial month of services at the start or at the conclusion of the project shall be prorated on a daily basis.

C. Quality Assurance. The consultant's fee is a fixed fee from the date of execution of this agreement until a final certificate of occupancy for the Lakeland School System athletic fields complex is issued. Throughout the term of the project, SES will maintain and annually provide to the Board a copy of the SES certificate of liability insurance.

D. SES Team Leaders. Dr. William Bozeman, Dr. Tim Fite, and/or Dr. James B. Mitchell, Jr. will be the primary partners providing the majority of the consulting services described in this agreement.

E. Termination of Services. The Board or SES may terminate this services agreement at will with a minimum of 30 days written notice to either party. Under such a termination, the Board will be invoiced, prorated on a daily basis, for services rendered as of the date

of termination at the time of receipt by SES of written notice from the Board of the decision to terminate such services.

This Contract sets forth the entire agreement between the Board of Education of the Lakeland School System, Lakeland, Tennessee and Southern Educational Strategies, LLC.
